In the event there is an emergency repair, leaking pipe, etc., a licensed plumber may turn the water off at the curb provided the plumber has contacted the Village Collector in advance. *Water service is not to be restored without the consent of the Village, failure to notify the Village will be constituted as theft of services.*

**On Site Requirement.** The Village of Carbon Cliff will *not* turn the water on nor turn the water off to your property unless the homeowner or a designated representative is on site and able to go inside and check for leaks. This indemnification applies to and includes, without limitation, the payment of all penalties, fines, judgements, awards, decrees, attorney's fees, and related costs or expenses, and any reimbursement to the Village of Carbon Cliff for all legal fees, expenses, and costs incurred by it.
