  - Ryan Ellis, 111 State Street, is seeking \$1,000.00 in compensation after maintenance located his water and sewer line on Christmas Eve during an emergency. Maintenance marked the water and sewer lines in the front of the property per the locate request; however, the sewer lateral repair ended up in the back of the property. Ryan feels the village did not mark his property correctly, and the plumber wasted time exploratory digging in the front yard when the break and repair were in the rear of the property. Water and Sewer lines are considered private lines, and the Village will only mark private lines if we can pick them up with our locator. Knowing where private lines are located is the responsibility of the homeowner. The locate request from Mr. Ellis states, "Locate: Front of the property \*\*\*urgent for then\*\*\*customer with limited service."

Most of this was planned to be completed through the USDA Loan Funding. IMEG is discussing with Hawkeye Land regarding easements by IAIS property at the Transmission Line.
