- B. Motion to approve the Lab Participation Notice & Invoice from the Illinois EPA Laboratory to handle chemical and radiological sampling from July 1, 2023, to December 31, 2023. IL EPA will be switching to a calendar year on January 1, 2024, if we agree to use IL EPA Laboratory for 2024, they will lock in our price now. The participation cost will be \$1,119.73. ION Environmental will be handling our coliform laboratory testing.
- C. Motion to approve the termination of a Pump Maintenance Contract with Mississippi Valley Pump, Bettendorf, Iowa.
- D. The Village of Carbon Cliff received a notice from Blackhawk Bank & Trust that the Village is currently overpledged, and they are requesting that the village release the \$200,000.00 security with the bank. This would bring the Village's pledged market value total to \$2,154,929.75 along with our \$250,000.00 FDIC insurance coverage. The village also has \$1,563,904.85 held in our repurchase transfer account, secured by another pledge account for repurchase transfers only. Motion to approve releasing the \$200,000.00 security pledge.
- E. Village Director, Nick Gottwalt and Village Engineer, Loren Rains selected Miller Trucking & Excavating as the lowest responsible bidder for the Oakwood Court Storm Drain Repair project. The contract was approved based on time and materials, not to exceed the amount of \$59,475.00.
- F. IMEG becomes New York Corporation. Effective April 1, 2023, IMEG Corp "IMEG" will merge into its wholly owned subsidiary IMEG Consultants Corp, a New York Corporation. This will not change any existing contracts the Village has with IMEG.
- G. The generator was delivered on Wednesday, March 22, 2023. Lakewood Electric and Crawford Company have finished making the final connections and we should have a running generator after the final inspections are complete.
- H. Update on the status of East Moline Water Connection.
- I. Review Policy on COVID-19. Currently, the White House is winding down the emergency protocols with an anticipated end on May 11th. Director Nick Gottwalt recommends following the White House and CDC guidelines and ending protocols when the government does.
