A. Monthly Update from ION Environmental.

Plant A—Switching the plant to running on PSI instead of tower level has definitely proved effective. We'll continue to operate that way from here on out. We have had multiple power issues as of late. At one point, we had a prolonged outage, but that was a town-wide issue. We have Britton looking at Well 2. It won't start. They megged the motor, and it reads fine, so we aren't considering replacing anything major. It appears to be the contactor. I know the plant only needs to make it to the fall for the new water hook-up, but keeping both wells in operation would be worthwhile until that time. The contactor should not be a super expensive fix. Chad also reminded the village that additional samples will be required by the EPA once we begin purchasing water from East Moline. The existing wells must also be capped, and the buildings could be used as storage or demolished.

- B. Motion to acknowledge and ratify Director Nick Gottwalt's hiring of Brandon Hopkey to the position of Maintenance Worker "Supervisor" with a start date of July 15th and an annual salary of \$58,240.00. The item was removed from the consent agenda as Mr. Hopkey called Tuesday morning to decline the offer after previously accepting it. Director Gottwalt informed the board that we still have several interviews lined up and aim to hire two maintenance employees.
