 - East Moline—Carbon Cliff Water Interconnect Project:
 - The village still needs to complete the construction of a pit near the railroad and booster on Valley View, as well as phase 2 of the IL 84 water main extension, before connecting to East Moline. Most of this was planned to be completed through the USDA Loan Funding.
 - USDA Loan Projects (PER)
 - Projects to be done under the USDA Loan:
 - Valley View Booster
 - IL 84 Phase 2 Water Main Replacement (McDowells to Xylem)
 - Old Colona Road Water Main Replacement
 - 3rd Street to Valley View Water Main Replacement
 - Mansur Avenue to Water Tower Water Main Replacement
 - Safe Routes to School (Eagle Ridge)
 - Loren will be looking into the application timeline for next year (5/15/24)
 - GIS Water & Sewer
 - Wastewater GPS/GIS mapping began on October 30, and Water GPS/GIS mapping will begin on or about November 12th.

 - Curb Appeal knows standing water is an issue and will work on a solution in the spring. They want to regrade the parking lot or install a French drain; however, concrete or thick asphalt is under the rock and is difficult to penetrate. They will also consider alternative solutions.
