- 3. Village Hall Roof: Ali with IMEG came out on December 15, 2022, to look at the roof. After inspection he noticed that 2 panels on the north and south side of the building are just full of holes. His initial thought was possibly shotty materials used when the roof was installed, however, Marcus noticed there seemed to be a pattern in the holes as if they were caused from the insulation being installed from inside the building. Ali recommended patching the holes or removing the panels and having new panels installed. Patch the holes using a rubberized sealant or tar.
