# Ordinance No. 2021-17

AN ORDINANCE PROVIDING FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2021,

AND ENDING DECEMBER 31, 2021,

OF THE VILLAGE OF CARBON CLIFF,

COUNTY OF ROCK ISLAND AND STATE OF ILLINOIS.

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Carbon Cliff, Illinois, as follows:

**SECTION ONE**: That the amount hereinafter set forth, or so much thereof as may be authorized by law, and the same are hereby levied upon all properties subject to taxation within the Village of Carbon Cliff as that property is assessed and equalized for the current year, and for such purposes as General Corporate, Police Protection, Garbage Disposal, and Street Lighting Taxes for the fiscal year of the Village of Carbon Cliff, Illinois, commencing on the 1<sup>st</sup> day of January 2021, and ending on the 31<sup>st</sup> day of December 2021.

**SECTION TWO**: That the amount levied for each object and purpose is placed in a separate column under the heading "Amount to be Raised by Tax Levy," which appears over same being as follows, to wit:

**SECTION THREE**: That the total amount of Two Hundred and Four Thousand One Hundred Dollars and zero cents (\$204,100.00) ascertained above, be and is hereby levied and assessed on all property subject to taxation within the Village of Carbon Cliff according to the value of said property as assessed and equalized for state and county purposes for the current year.

**SECTION FOUR**: This Levy Ordinance is adopted pursuant to the procedures set forth in the Illinois Municipal Code.

**SECTION FIVE**: That there is hereby certified to the County Clerk of Rock Island County, Illinois, the several sums above, constituting said total amount, and the total amount of Two Hundred and Four Thousand One Hundred Dollars and zero cents (\$204,100.00), which total amount the Village of Carbon Cliff requires to be raised by taxation for the current fiscal year of the Village, and the Village Clerk of the Village is hereby ordered and directed to file with the County Clerk of the County on or before the time required by law, a certified copy of this Ordinance.

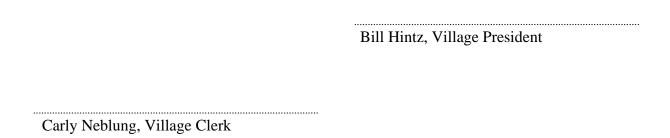
**SECTION SIX**: If any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

**SECTION SEVEN**: This ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
