ORDINANCE NO. 2022-06

“AN ORDINANCE AMENDING TITLE II, ARTICLE 7, SECTION 20 OF THE VILLAGE CODE, GARBAGE COLLECTION FEES.”

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Carbon Cliff, Rock Island County, Illinois as follows:

**SECTION ONE:** Title II, Article 7, Section 20 of the Village Code of the Village of Carbon Cliff, Illinois, is hereby deleted.

**SECTION TWO:** Title II, Article 7, Section 20 of the Village Code of the Village of Carbon Cliff, Illinois, shall be as follows:

**“Garbage & Recycling Collection”** Every residence shall pay a monthly fee for garbage and recycling collection, and disposal. The fees for all available services are as follows:

(A) Retroactive to ***July 1, 2022***, the following schedule shall be in effect:

Duplex dwelling (per unit).....	\$ 17.00
Multi-family dwelling (per unit) <i>no apartment complexes</i> .....	\$ 17.00

Cart Delivery / Removal .....	\$ 25.00
Bulk Item / Special Collection.....	\$ 20.00

(B) As of ***January 1, 2023***, the following schedule shall be in effect:

Yard Waste Stickers (individual sticker) .....	\$ 3.25

Cart Delivery / Removal .....	\$ 25.00
Bulk Item / Special Collection.....	\$ 25.00

**SECTION THREE:** These fees shall pertain to all bills issued after the effective date of this Ordinance.


**SECTION FOUR:** The fees established in this Ordinance shall be retroactive to July 1, 2022.

**SECTION FIVE:** That this ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, published by authority of the Corporate Authorities, as provided by law.
